## Promotion Terms

### “B2B Start Bonus Promotion - Edition 2026”

#### §1 Definitions

1. **Organizer** - Krakman P. Kiepura, K. Michalik sp.k. with its registered office in Poland (Pollanki 18, 30-740 Krakow, Poland, tel. +48 123626134, e-mail: [krakman@taiwangun.com](mailto:krakman@taiwangun.com)), entered into the Register of Entrepreneurs maintained by the District Court for Kraków - Śródmieście, 11th Commercial Division of the National Court Register under KRS number 0000567135, REGON 122593008, VAT PL6793082897.
2. **B2B Store** - the Organizer's B2B online store operated at [www.taiwangun.biz](http://www.taiwangun.biz).
3. **New Partner** - a company meeting the industry criteria specified in §2, which does not have a registered account in the B2B Store on the promotion start date and has not had one in the 12 months preceding the promotion start date.
4. **Inactive Partner** - a company that meets the industry criteria and has a registered account in the B2B Store but has not made any purchases in the last 12 months.
5. **Start Bonus** - an individual, unique code entitling to receive a bonus for an order in the B2B Store in the amount specified in §4.

## §2 General provisions

1. The promotion runs from January 1, 2026, to December 31, 2026.
2. **The promotion is directed to New B2B Partners operating as:**
  - a. airsoft stores
  - b. military stores
  - c. outdoor and related stores
  - d. airsoft dedicated arenas
3. All amounts in EUR are net amounts (VAT 0%), while amounts in PLN are gross amounts (including VAT according to the rate applicable in Poland).

## §3 Participation requirements

1. **The promotion applies only to orders placed in the B2B Store.**
2. The promotion is available to business entities that:
  - a. For EU companies: have an active VAT number verified in the European VIES system.
  - b. For Polish companies: have an active NIP number and are registered as active VAT payers.
  - c. For non-EU companies: have an active tax identification number in their country of residence.
3. Providing false data during registration results in exclusion from the promotion and may lead to a claim for payment in the amount corresponding to the price reduction obtained through the unjustifiably acquired bonus.

## §4 Promotion rules

1. **Under the promotion, a new B2B Partner receives a bonus of:**
  - a. for companies from Poland: 250 PLN gross (including VAT),
  - b. for companies from other countries: 50 EUR net (VAT 0% for intra-community acquisition or export).

2. The bonus is awarded in the form of an individual, unique promotional code to be used with an order in the B2B Store.
3. The bonus reduces the order value by the bonus amount.
4. Bonus usage conditions:
  - a. **The code must be used within 60 calendar days from the date of receipt.**
  - b. Standard minimum order value conditions apply as per general B2B cooperation terms.
  - c. The bonus can be used only once.
  - d. The bonus cannot be exchanged for cash.
5. In case of individual invitations sent to Inactive Partners, the 60-day period for using the bonus is counted from the date of sending the invitation.

## §5 Exclusions and limitations

1. The promotion cannot be combined with:
  - a. other promotional offers for starting cooperation,
  - b. individual arrangements regarding the start of cooperation, including those concerning the reduction of minimum order value.
2. The Organizer reserves the right to:
  - a. verify the fulfillment of participation conditions,
  - b. exclude a participant in case of violation of the regulations,
  - c. terminate or change the promotion conditions while maintaining the acquired rights of participants.

## §6 Data processing

The data controller is the Organizer. Data will be processed for the purpose of: implementing the promotion; fulfilling legal obligations, including tax and accounting; pursuing or defending against claims. Detailed information about data processing can be found in the privacy policy available on the Organizer's website.

## **§7 Complaints and disputes**

1. Complaints can be submitted electronically to the email address [krakman@taiwangun.com](mailto:krakman@taiwangun.com).
2. The complaint submission should include:
  - a. company name and contact details of the submitting party,
  - b. order number or promotional code to which the complaint relates,
  - c. description of the complaint.
3. Any disputes arising from this promotion will be resolved amicably in the first instance, and in the absence of agreement, by the court competent for the Organizer's registered office.

## **§8 Final provisions**

1. Participation in the promotion means acceptance of these terms and conditions.
2. In matters not regulated, the Organizer's general B2B cooperation terms apply.
3. The terms and conditions have been prepared in Polish and English, with the Polish version being binding in case of discrepancies.
4. These terms and conditions are governed by Polish law.
